In any month where the accrued interest is less than \$5.00, a \$5.00 service charge will be payable in lieu of interest. Customer agrees to be responsible for any legal fees or additional costs incurred in connection with collection of the account.

Turkstra Lumber Company Limited will not be responsible for damages, directly or indirectly caused, by product failure and/or delayed delivery. Liability will be limited to replacement of defective product.
